It Only Takes One Gap to Fail Compliance

One missed log or control can cost your contract. CMMC Level 2 gaps now mean lost trust and revenue.

What Feels Minor Can Lead to Major Penalties

One missing policy can cost more than a breach. The DoD now enforces audits and proof at every level. Many contractors still fall behind on documentation and training. Compliance isn't paperwork it's protection. It secures contracts, strengthens credibility, and keeps business moving.

2025 Compliance Check: True Stories

1. Contract Paused: CMMC Gap

A Virginia subcontractor failed a CMMC review for missing MFA and training. Their contract was paused, delaying work and causing delays.

Compliance Gap: Outdated access protocols. Without audit logs or user tracking, they failed verification costing three weeks of downtime and client trust.

2. Access Denied: Expired Cert.

5 CMMC MISTAKES THAT COST CONTRACTS

1. No Evidence = No Compliance

Last October, a Maryland defense contractor failed a Level 2 review when assessors found missing MFA proof and incomplete training logs. The contract was suspended pending remediation. With deadlines missed and deliverables frozen, the company lost months of revenue and reputation.

- **One overlooked control can halt contracts, payments, and progress.**
- **Without documented evidence, compliance claims collapse under review.**
- **Readiness isn't a one-time task it's an ongoing discipline your business depends on.**

2. One Gap - Instant Suspension

A Virginia subcontractor's renewal audit revealed missing MFA records and outdated policies. The DoD paused their eligibility until evidence was verified. Work stalled, invoices froze, and reputation took a hit.

- **Even one missing control can halt progress.**
- **Update policies and training before renewal reviews.**

3. Evidence Missing = Money Lost

In September 2025, a Midwest manufacturer lost a \$1.2 million renewal because screenshots and logs were scattered across departments. Reviewers flagged "incomplete evidence."

- **Centralize documentation and version tracking.**
- **Assign one compliance owner per CMMC control.**

4. "We Still Didn't Know" Violation

A defense vendor claimed ignorance of new DoD clauses. Their contract was pulled after a failed spot check. Regulators don't excuse oversight they document it.

- **Monitor rule updates and attestation deadlines.**
- **Schedule quarterly gap reviews with your CMMC advisor.**

5. Outdated Systems = Failure

A contractor using legacy servers failed vulnerability scans during a Level 2 assessment. Without patch logs or mitigation plans, they couldn't certify.

- **Outdated systems are Easy Targets.**
- **Missed updates = Open Doors for Cybercriminals.**
